

## **AEF Grosses Montagny 149, for Anthonius de Aventhica, commissaire Vignerosi, 1439-1446.**

*Abstracts prepared by John W. McCoy ([RealMac@aol.com](mailto:RealMac@aol.com)) © 2014.*

The index is badly damaged, torn, and disintegrating, to the point where most entries cannot be read in full. Further, the first 10 folios of the main text have been damaged by moisture, with the result that much of text on the top half of each of these pages is faded to the point of invisibility. Consequently, the names of the parties and some other details on these pages have to be inferred from the rest of the text. The reconnaissances bear the signature and paraphe of A. ? (or possibly Mermerius?) Vignirosi. The foliation is uncertain; some of the original folio numbers are illegible or not even visible, and in some places modern numbers, in pencil, have been substituted.

The terrier was compiled, according to the text of the individual reconnaissances, for Nobilis Anthonius de Aventhica filius quondam Nobilis Uldrici de Aventhica filii quondam Nobilis Johannes de Aventhica. For some locations, for which the reconnaissances do not specify the names of the previous tenants, it appears that properties had simply been leased for a fixed term, or possibly for the lifetime of the tenant, and that the reconnaissants had entered into a new lease at some time in the recent past.
