Main sections:

- pp. 1-43: procedural matters, 16 aug 1742 08 sep 1742, including registration of 91 separate claimants against the property of Isaac and Gabriel Monod.
- pp. 43-63: procedural matters 01 oct 1742 29 nov 1742, including sales of property and changes of claims or representations by various claimants and their spouses or relatives.
- pp.63-91?: 17 jan 1743?, enumeration of debts, more or less in alphabetical order by creditor. Marginal "f" numbers refer to the second set of page numbers in the register of debts and payments on pages 344-483. Marginal "n" numbers refer to a numbered list of properties?
- pp.101-131: 29 aug 1742 « Taxe des fonds que possedent Messieurs les frères Isaac & Gabriel Monod Conseigneurs de Yens, Ballens, & Froideville ». Properties at Yens, numbered 1-78.
 - pp. 133-182: Properties at Ballens, numbered 1-90.
 - p.183 : « Etat de la paille du dixme de Ballens. »
 - pp. 184-185?: « Etat general des censes... riere Ballens »
 - pp. 189-191: « Etat general » relating to property held jointly with Daniel Bickard, etc.
 - pp. 193- ?: "Etat du seigneurial de Froideville".
 - pp. 199-232: « Taxe du bien de Biere », numbered 1-60.
- pp. 235- 266: « Taxes des biens ... riere » Lausanne, St. Livres, Tertegnin, Mont, Feschy, Berolle, Mollens.
 - pp. 269-282: Another list of properties, not numbered.
 - pp. 283-331: Inventory of personal property.
 - pp. 332-337: Personal property sold at auction at Yens, 22 oct 1742.
- pp. 340-343: Index to register of amounts owed by those who purchased property at auction, and payments they made. Amounts paid by these purchasers are then paid out to various creditors.
 - pp. 344-483: Register of such debts, receipts, and payments.
 - pp. 489-558: List of debts contained in specific instruments and how these debts were settled.

pp. 559-571: Inventaire des papiers. A numbered list (copies of?) of documents or groups of documents that were gathered during the settlement process. These papers should have been part of the archives of the Bailliage de Morges, or possibly of the city of Morges. Among these (no. 15) is a letter of bourgeoisie for Félix Monod for the commune of Yens, 02 jul 1660, signed Mayor and Pittet.
