

ACV Aa 2/2 Copy register for the Inventaire Blanc, district of Avenches, Supplement.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2020.

The spine of this volume is labeled “Suplément – Avenche – Tom. I”, even though it is catalogued as the second of three volumes of copy registers for this district. The title page explains the contents: “Tomus I, continens diversa Legata, Testamenta, Acquisitiones, Donationes et Regonitiones Homagiorum ac Decimatarum, per diligentem Revisionem ac Strenuam Inquisitionem reperta inter quadsam Litteras et Instrumenta Sub Titulo et Nomine inutilium Regonitionum olim dejecta, De Anno 1249 jusque ad Annum 1536.” In other words, these are transcriptions of miscellaneous documents that were not inventoried in the original Inventaire Blanc. There are 94 items. They are abstracted here so that it will be possible to locate them (of at least their transcripts !) more easily.

The date 1249 listed on the title page does not agree with the contents! The first item is dated both in its title and in the text in 1349. Is it the date 1249 on the title page that is in error, or is it the date in the first item itself that is incorrect? A more careful reading might settle the question, but the item No. 2 is dated in 1344, and all the rest of the documents seem to be in chronological order. As a result of the integration of the old inventory of “Nouveaux Titres” into the on-line catalogue, it has been possible to identify all but one of the items in this series in the modern catalogue of the ACV, and in some cases, to reveal probable errors in the dates found in Aa 2/2. The existence of a corresponding entry in the “Nouveaux Titres” tells us that the original document had been transported from Bern and had survived in the collections of the ACV at least until the early 20th Century. However, items designated NF in the catalogue of the ACV refer to transcriptions of the inventory of the “Nouveaux Titres” rather than the documents themselves, but the latter may frequently be located in some part of ACV C XX, and in the present case, most likely in the collection for Avenches, C XX 33, the inventory of which still lacks almost entirely any description except the date, which, because of the condition of the documents, may not always be reliable.



No. 1: Petrus de Adventhica dyaconus filius quondam Coleti dicti de Eyssy burgensis de Adventhica sells to Dominus Cono de Adventhica capellanus altaris seu capellae Beati Andreae in ecclesia Beati Martini de Adventhica, signed Guillermus de Villarepos presbiter, 09 feb 1349. (NT “Nouveaux Titres” description now catalogued as C XXII NF10416, dated 09 jan 1349/1350.)

No. 2: Borcardus de Adventhica miles filius quondam Johannis de Adventhica domicelli filii quondam Rodulphi de Adventhica militis, et Johanneta eius uxor, sell to Dominus Uldricus filius quondam Cononis dicti de Cudriffin (text in the copy register says Cudristin!) burgensis de Adventhica, censes owed by Contesseta, mother of the said Dominus Uldricus as well as by the said Uldricus and his sister Jaqueta, approved 17 nov 1344 by the said Borcardus, and by Johanneta his wife 03 dec 1344. (NT description now catalogued as C XXII NF10412.)

No. 3: Cono de Adventhica capellanus altarum Sanctorum Johannis et Andreeae in ecclesia Beati Martini de Adventhica, sells to Dominus Uldricus curatus de Donnathecla dilectus frater meus, ?? dec 1351. (NT description now catalogued as C XXII NF10420.)

No. 4: Perrodus filius quondam Aymonis dicti Jojo (probably = Joyo, Joyoz) burgensis de Adventhica with approval of his wife Mermeta and his son Petrus sell to Dominus Petrus dictus Pega de Adventhica recipiens nomine et ad opus dicti hospitalis pauperum Beatae Mariae Virginis de Adventhica, rector et gubernator dicti hospitalis..., notary Cono Pucel de Adventhica clericus and copied after his death by Petrus dictus Bonjor, 08 dec 1356. (NT description now catalogued as C XXII NF10423.)

No. 5: Rodulphus de Adventhica domicellus filius quondam Domini Petri de Adventhica militis sells to Dominus Cono curatus de Dondidier procurator sacerdotum et cleri de Adventhica, notary Petrus Bonjor, 12 feb 1361. (NT description now catalogued as C XXII NF10436.)

No. 6: Katerina relicita Perrodi Girardi quondam de Adventhica nunc uxor Johannodi dicti de Belfoz with approval of her husband and of Petrus her son by her late husband, and at the request of Johannis dicti Chastellan de Adventhica domicellus advocatus mei dicti Petri sell to the clergy of the church of St. Martin in Avenches, cense (loan secured by their house in Avenches), notary Dominus Cono dictus de Porat (elsewhere de Porta, which is more likely correct) presbiter dicte curie nostri, signed quo ad nos Katerinam et Johannodum conjuges predictos ?? may 1366, et quo ad nos Petrus et Johannem dictum Chastellan antedictos ?? apr 1372. (NT description now catalogued as C XXII NF10443.)

No. 7: Johanodus filius Perrodi allumpni quondam Rodulphi de Oleris morans Adventhice, with approval of his wife Alexia filia quondam Johannodi Joly de Adventhica sells to the church of Avenches, cense, notary Perrodus Bonjor, 23 mar 1366. (NT description now catalogued as C XXII NF10441.)

No. 8: Johannodus dictus Avenchae filius quondam Uldraseti filii Jordani de Outrejour ? de Adventhica quondam, with approval of his wife Becheta dicta Porchieri de Friburgo sell to Dominus Uldricus de Aventhica curatus de Donnatecla filius quondam dicte Contessone de Aventhica, all claim ? on unum pratum situm in territorio de Aventhica in loco dicto ou Pereis Fillies Jordan inter campum Uldrici filii ou Rossel a parte boree et pratum Perrodi Gachi (probably = Gachet) a parte venti affrontant a parte orientis prato ecclesie de Donnatecla, prato Perrissone filie Jordani de Outrejour ? Aventhice a parte occidentis, notary Johannes de Cudriffin, 02 dec 1368. (NT description now catalogued as C XXII NF10447. The original is likely C XX 33/32, same date.)

No. 9 : Johanneta filia quondam Vulliermi dicti de Oleres de Dondidier uxor Johannodi dicti de Leschieres de Adventhica clericci et Johannes, Vulliermus, ac Richardus fratres dictorum conjugum filii in estate legitima, sell various items to Perrodus dictus Bonjor de Adventhica notarius, censes owed by Uldricus dictus Gover de Dompnathecla, Agnelleta relicita Roleti dicti Pillicet de Dompnathecla, Johannodus dictus Geneveis de Donnathecla, Perrodus Sarrasin et Roletus Burriliat, Uldrasetus Barrilliac (perhaps Barrilliat ?), notary Cono [de Adventhica] curate

of Domdidier, ?? oct 1375, and for the approval of the children ?? nov 1380. (NT description now catalogued as C XXII NF12355.)

No. 10 : Williermus dictus Mique de Adventhica presbiter sells to Dominus Cono de Adventhica presbiter curatus de Donnoderio, cense, notary Johannes dictus de Lescheries clericus, 16 feb 1370. (NT description now catalogued as C XXII NF12252.)

No. 11 : Petrus filius quondam Domini Petri Maioris de Adventhica militis sells to the church of Dompnathecla ac capelle hospitalis pauperum indigencium Beate Virginis Marie de Adventhica, censes owed by Johannodus Blanchoz, Perrodus Beir, Jacobus maritus Mermete filie quondam Johannodi Puttoz, Mermetus Barberii de Missie, Perrodus Rolie de Missie, (one or more of these censes are dedicated to the repose of the soul of the late Johannodus filius quondam Martini de Adventhica), notary Guilliermus Marie notarius and copied after his death by Perrodus Bonjor, 15 nov 1371. (NT description now catalogued as C XXII NF10453.)

No. 12: Petrus de Adventhica filius quondam Domini Petri militis filii quondam Cononis de Adventhica domicelli, with approval of his second wife Jaqueta, sells to Cono de Adventhica curatus de Dondidier procuratorioque cappellanorum et universitatis cleri de Adventhica, censes owed by Jaquetus Perrilliodi de Adventhica, notary Dominus Cono de Porta curatus de Bellaripa, 01 dec 1374. (NT description now catalogued as C XXII NF10458.)

No. 13: Johannes de Prez domicellus castellanus de Adventhica, Perrodus filius quondam Domini Petri militis, Petrus maior, Petrus junior, Johannes filius quondam Johannis de Adventhica domicelli, Petrus Uldrigon, Johannodus Pega, Cono Tervalanti, Petrus de Donnopetro, Johannes Vassaul, Borcardus Clochie, Cono dictus Tacholaz, burgenses et consules dicti loci de Adventhica, sells to Cono de Adventhica curatus de Dondidier, censes owed by Petrus dictus Perrin and Jacobus dictus Curbilliar, notary Dominus Vulliermus de Porta presbiter, 16 nov 1377. (NT description now catalogued as C XXII NF10461.)

No. 14: Cono de Adventhica presbiter curatus parochiali ecclesie de Dondidier rectorque ac nomine rectorio capelle seu altaris Beati Andree Apostoli in ecclesia Beati Martini de Adventhica, with approval of Petrus maior et Petrus junior de Aventhica domicelli patrones dicte capelle, accension for Ysabella relicta Mermeti Guynchet de Visin residens Adventhice, notary Dominus Vulliermus de Porta presbiter, 31 mar 1379. (NT description now catalogued as C XXII NF10464.)

No. 15: Hugonet filius quondam Bononis Griboler burgensis de Adventhica, with approval of Dominus Vulliermus de Micquez presbiter procurator et nomine procuratorio capellanorum dicti loci, as well as Petrus filius quondam Domini Borcardi de Aventhica militis, sell to Mermetus filius quondam Johannodi Parperat de Dondidier nunc morans Aventhice, notary Vulliermus de Porta, 18 jun 1380 (millesimo tercentesimo septuagesimo decimo!). (NT description now catalogued as C XXII NF10465.)

No. 16: Mermetus Greboleir de Aventhica carpentator, notice of testament, listing the religious bequests only, notary Guilliermus Marie, 22 nov 1383. (NT description now catalogued as C XXII NF10479, dated 22 dec 1383.)

No. 17: Willermus dictus Alaman de Crissie et Anguynesa eius uxor burgensis et residens Aventhice, donation to the church of Avenches, cense, notary Guilliermus Marie, 10 dec 1383. (NT description now catalogued as C XXII NF10472.)

No. 18: Alexia uxor Cononis Gruvyar? de Aventhica with approval of her husband, donation to the church of Avenches, cense, notary Guilliermus Marie, 22 sep 1383. (NT description now catalogued as C XXII NF10470.)

No. 19: Conodus Bonjor de Adventhica filius Stephani Bonjor de Adventhica with approval of his father and of Cristina his wife sells to Marmodus dictus Curbilliar de Adventhica carpentator, cense, notary Guilliermus Marie, 28 oct 1386, and approved by Stephanus in March of the same year. (NT description now catalogued as C XXII NF10484.)

No. 20: Petrus dictus Emonier de Aventhica carpentator sells to Roletus dictus Saioz (=Sajoz, Sage, or Sapientis) burgensis Aventhica carpentator, cense, notary Guilliermus Marie, ?? may 1388. (NT description now catalogued as C XXII NF10487.)

No. 21: Roletus Mussy de Aventhica et Jaqueta eius uxor sell to Guilliermus Marie notarius de Aventhia, notary Dominus Johannes Uldrigon presbiter, 08 jan 1391. (NT description now catalogued as C XXII NF10496.)

No. 22: (Misnumbered as 23) Conodus Oyar de Adventhica filius quondam Johannodi Trevalanyty, abstract of testament listing only the religious bequests, notary Guilliermus Marie, 27 apr 1392. (It was customary at this period for the notary to make a separate abstract of the religious bequests, with the same date as the testament itself, for the use of the local religious institutions. Frequently it is only this abstract that has survived.) (NT description now catalogued as C XXII NF10500, but see additional documents of the same date relating to the same donation NF10501 and NF 10503.)

No. 23: Jaqueta filia quondam Mermeti Embruti de Adventhica, abstract of testament listing only the religious bequests, notary Johannes Vassaud, 12 jan 1392. (NT description now catalogued as C XXII NF10497 and another copy NF10506.)

No. 24: Hugonetus Bononier (probably Bovonier?) burgensis Aventhica, abstract of testament listing only the religious bequests, notary Johannes Vassaud, 05 apr 1393. (NT description now catalogued as C XXII NF10508 and another copy NF10509.)

No. 25: Johanneta uxor Johannis Chastellan de Adventhica domicelli, abstract of testament listing only the religious bequests, mentions bequests for repose of the souls of her husband and of sons Johannes et Uldricus, each approving and therefore still living, notary Guilliermus Marie, 25 nov 1396. (NT description now catalogued as C XXII NF10514 and another copy NF10515.)

No. 26: Francesia dicta Gevillieta (probably Genillieta?) uxor Perrodi dicti Pollet de Adventhica, quod cum dictus (obvious error for Dompnus!) Johannes Bonifilii (=Bonfils) curatus Aventhice sold to the said Francesia a cense, recorded by Johannes Vassaud clericus, now the said Francesia makes a donation of the said cense after her death to the church of Avenches, notary

Johannes Vassaud, die Martis post festum Nativitatis Beati Johannis Baptiste 1396. (NT description now catalogued as C XXII NF10518.)

No. 27: Mermetus Borcar de Adventhica domicellus filius quondam Perrodi filii quondam Domini Borcardi de Adventhica sells to Dompnus Petrus Botteral (=Bocterel) presbiter procurator et nomine procuratorio cleri de Adventhica, cense, on duas posas terre sitas en Riaul de longitudine terre predicti Johannis domicelli a parte venti et terre Gachete a parte boree, notary Guilliermus Marie, 30 may 1397. (NT description now catalogued as C XXII NF10520.)

No. 28 : Johannes Bonfil (=Bonfils) curatus de Aventhica nomine ecclesie mee et cleri eiusdem loci, Wulliermus de Eissy, Wulliermus Mique, Johannes Uldricon et Johannes Pittet de Aventhica capellani nomine nostre et tocius cleri de Aventhica, accensation for Mermetus Borcar de Aventhica domicellus, quoddam cassale cuiusdam domus que quondam fuit Roleti Cler et Uldriserii Tiery situm Aventhice, notary Guilliermus Marie, die Dominica post festum Nativitatis Beate Marie Virginis 1398. (The title says that the property is in Payerne, but the text places it in Avenches !) (NT description now catalogued as C XXII NF10522.)

No. 29: Roletus Cuanens burgensis Aventhice filius quondam Perrodi Cuanens de Villarespoz with approval of his wife Marguereta filia quondam Johannodi Blanchoz sells to Mermetus Borcar de Aventhica domicellus filius quondam Perrodi filii quondam Domini Borcardi dicti loci militis, notary Guilliermus Marie, 08 sep 1399. (NT description now catalogued as C XXII NF10524 and another copy NF10678.)

No. 30: Johannes Bonifilii (=Bonfils) curatus Aventhice, donation to the church of Avenches, notary Johannes Vassaud clericus dicte curie nostri decanatus Aventhice, 13 sep 1401. (NT description now catalogued as C XXII NF10536, dated 30 sep 1401.)

No. 31: Uldriodus dictus de Treval de Aventhica domicellus, donation, pro remedio et salute animarum quondam Girardi allumpni mei et matris eius, to the church of Avenches, cense purchased from Francesia relicta Uldrici de Adventhica, notary Petrus Cuaneti clericus, vigilia festi Beate Marie Magdalene 1403. (NT description now catalogued as C XXII NF10539.)

No. 32: Jaquetus dictus Bonjor de Aventhica faber sells to Johannes antenatus de Aventhica domicellus rector cappella Beati Anthonii site prope villam Aventhice, cense owes by Uldricus dictus Michiel alias Orfino de Aventhica, notary Petrus Cuaneti, 26 nov 1404. (NT description now catalogued as C XXII NF10544.)

No. 33: Ysabella dicta Costantinaz relicta Petri Costantin lathomi burgensis Aventhice, abstract of testament listing only the religious bequests, notary Guilliermus Marie, die Dominica ante festum Purificacionis Beate Marie Virginis 1405. (NT description now catalogued as C XXII NF10549 and another copy NF10550.)

No. 34: Ysabella dicta Costantinaz de Aventhica relicta Petri Constantin lathomi burgensis Aventhice, abstract of the same testament, additional religious bequests to Petrus de Monte Presbiter (=de Montpreveyres) dyaconus natus (this word, used in place of the expected filius, seems to emphasize his extra-marital origin) quondam Domini Jacobi de Monte Presbitero

capellani, notary Guilliermus Marie, die Dominica ante festum Purificationis Beate Marie Virginis 1405. (NT description now catalogued as C XXII NF10547 and NF11625.)

No. 35: Francesia Bardaz de Aventhica filia quondam Uldriferii Bonjor de Aventhica, abstract of testament listing only the religious bequests, notary Guilliermus Marie, 10 may 1406. (NT description now catalogued as C XXII NF10552.)

No. 36 (1): Uldricus Fisrol burgensis Aventhie, donation to his wife Nychola, unam posam terre sitam in territorio Aventhice videlicet loco dicto Ultra Lungam Aquam juxta terram Ludovici dicti Burgognyon quam tenet ab heredibus Petri Maioris de Aventhica domicelli a parte auberrerie, et terram Stephanodi dicti Botterel quondam a parte jorani, affrontantem dicte lunge aque a parte boree. Item, et unum cassale situm in dicto territorio de Aventhica loco dicto in Sisy juxta cassale Mermete uxoris Jaqueti dicti Pignyolet a parte auberrerie, et casale Perrodi dicti de la Fromendery a parte jorani, affrontans vie publice a parte venti, notary Petrus Cuaneti, 28 jan 1406 *secundum stilum curie Lausannensis* sumpto. (NT description now catalogued as C XXII NF10553.)

No. 36 (2) : Nychola uxor Uldrici dicti Fisrol burgensis Adventhice with approval of her husband, donation to him, apparently the same properties listed in the preceding item, notary Petrus Cuaneti, 28 jan 1406. (In effect, they used these donations to assure that, whichever of them died first, the survivor would have full title to these properties.) (NT description now catalogued as annex to C XXII NF10553.)

No. 37: Petrus dictus Campanat de Adventhica et Perissona eius uxor sell to Dominus Williermus Sugnyens capellanus et rector capelle Beati Michaelis Archangeli fundate in ecclesia Beati Martini de Adventhica, notary Petrus Cuaneti, 08 apr 1408. (NT description now catalogued as C XXII NF10458.)

No. 38: Johannes dictus Drochat de Adventhica (with approval of his wife Nycholeta) sells to Dominus Wernherus Wisentag curatus parochialis ecclesie Beati Martini de Adventhica, notary Petrus Cuaneti, 20 may 1408. (NT description now catalogued as C XXII NF10559 and another copy NF10560.)

No. 39: Uldricus dictus Fisrol burgensis de Adventhica Lausannensis dyocesis, with approval of his wife Nychola, testament, universal heirs Petrus dictus Uldrigon burgensis Adventhice filius quondam Petri dicti Uldrigon, abstract of religious bequests, notary Petrus Cuaneti, 19 nov 1410. (This is the first example in this group of an abstract of a testament that includes the universal heirs as well as the religious bequests. Presumably, the religious institution would find this additional information useful, in the event they had to sue the heirs for fulfillment of the religious bequests.) (NT description now catalogued as C XXII NF10569-NF10574, six separate items, see also below, No. 40.)

No. 40: Uldricus dictus Fisrol burgensis Adventhica, another abstract of testament, further religious bequests, notary Petrus Cuaneti, 19 nov 1410. (NT description now catalogued as C XXII NF10569-NF10574, six separate items, see also above, No. 39.)

No. 41: Johannodus Guichar alias Rossalet de Dompnothecla prope Aventhicam sells to Dominus Petrus Botterel capellanus rector receptor et gubernator cleri de Adventhica, cense bequeathed by the late Dominus Willermus Mique capelanus Aventhice to the said clergy, notary Guilliermus Marie, 12 dec 1410. (NT description now catalogued as C XXII NF10575.)

No. 42: Wernherus curatus parochialis ecclesie Beati Martini de Adventhia, accensation for Johannes dictus Juglard de Adventhica, notary Petrus Cuaneti, 24 feb 1412. (NT description now catalogued as C XXII NF10592, dated 25 feb 1412.)

No. 43 (1): Petrus de Monte presbiter capellanus residens Adventhice sells to Johannes dictus Colin sartor residens Adventhice, notary Petrus Cuaneti, 20 aug 1412. (NT description now catalogued as C XXII NF10589, includes also No. 43 (2), below.)

No. 43 (2): Johannes dictus Colin sartor residens Adventhice owes cense to Domimus Petrus Botterel capellanus procurator et nomine procuratorio cleri Adventhice, notary Petrus Cuaneti, 17 nov 1412. (NT description now catalogued as C XXII NF10589, includes also No. 43 (1), above.)

No. 44: Conodus dictus Drochat de Adventhica et Jaqueta eius uxor sell to Dominus Girardus Medici capellanus procurator et nomine procuratorio cleri Adventhice, various censes, owed by Agnelleta quondam uxor Heinrici dicti Cilabrat de Adventhica, Francesia uxor quondam Guilliermi Marie notarii, Roletus filius quondam Rodulphi dicti Marier de Adventhica (presumably the same family as Guilliermus Marie), notary Nycholaus Cuaneti clericus, 01 jan 1426. (NT description now catalogued as C XXII NF10640.)

No. 45: Reynaldus dictus Chiviliard curatus de Morens rector et nomine rectorio capelle Beati Michaelis Archangeli fundate in ecclesia parochiali Beati Martini de Adventhica, accensation for Petrus dictus Campanat de Adventhica junior, notary Nycholaus Cuaneti, 17 sep 1426. (NT description now catalogued as C XXII NF10638.)

No. 46: Petrus dictus Pitijohan residens Adventhice sells to Nychodus dictus Uldriod de Rueria residens Adventhice, notary Nycholaus Cuaneti, 21 nov 1429. (NT description now catalogued as C XXII NF10646 and another copy NF10647.)

No. 47: Reinaldus Chiviliard curatus de Morens rector et nomine rectorio capelle Beati Michaelis Archangli fundate in ecclesia parochiali Beati Martini de Aventhica, accensation for Petrus dictus Campanat de Adventhica junior, notary Nycholaus Cuaneti, 07 mar 1429. (NT description now catalogued as C XXII NF10649.)

No. 48: Petrus dictus Uldricon de Aventhica antenatus, sale to Dominus Girardus Campaneti de Aventhica capellanus procurator et nomine procuratorio cleri Aventhice, censes, one owed by Dominus Petrus Ruerat quondam curatus Friburgi, notary Nycholaus Cuaneti, 07 dec 1430, signed Clemens Ravanelli. (NT description now catalogued as C XXII NF10650.)

No. 49: Johannes dictus Uldricon de Aventhica sells to Dominus Otho Masaleir de Aventhica capellanus rector et nomine rectorio capelle Beati Michaelis Archangeli fundate in ecclesia

parrochiali Beati Martini *supra ossa defunctorum*, notary Petrus Sapientis, 27 feb 1434. (NT description now catalogued as C XXII NF10659.)

No. 50: (In French) Jean de Pringins, Bishop and Count of Lausanne, at the request of Pierre Simonet et Pierre Dagie de Faoug recteurs et gouverneurs de nostre village de Faoug au nom et de la part de toute la communauté et des bonnes gens de nostre dit village de Faoug, grant of omguelt et les oboles du vin vendable en nostre dicte village de Faoug par l'espace de 30 ans, notary Rolet de Dompierre, en nostre chataux de Lucens 22 nov 1437, translated from the Latin original which was duly signed and sealed with red wax, the transcript signed by Bock, notary of Morat. (Original, meaning the translation signed by Bock, now catalogued as C IV 505.)

Nol. 51 : Nichodus Perrinaul de Aventhica curatus de Foz et capellanus capelle Beati Petri fondate in ecclesia parrochiali Beati Martini de Aventhica, abstract of testament listing religious bequests, mention bequest to Perrisonna uxor Anthonii dicti Bosset de Aventhica ancilla mea, who is the subject of additional bequests, notary Nicholaus Cuaneti, 28 jun 1438. (NT description now catalogued as C XXII NF10666 and another copy NF10669.)

No. 52 : Petrus dictus Fornerod burgensis Aventhice with approval of his wife Beatrix sells to Johannes dictus Digolet et Mermetus dictus Bonjor burgenses Aventhice rectores hospitalis Beate Marie de Aventhica, notary Nycholaus Cuaneti, 30 mar 1440. (NT description now catalogued as C XXII NF10677.)

No. 53: Otho Perryn de Adventhica sells to Dominus Girardus Medici capellanus curatus parrochiali ecclesie Sancti Martini de Aventhica, notary Nychodus Bonjor, 07 apr 1450. (NT description now catalogued as C XXII NF10701.)

(NT description now catalogued as C XXII NF10705.)

No. 55: Williermus de Dompnopetro filius Anthonii de Dompnopetro quondam burgensis Aventhice with approval of Petrus Uldrigon notarius tutor meus sells to Dominus Johannes de Radice capellanus et rector capelle Beati Michaelis Archangeli fundate in ecclesia Beati Martini de Aventhica *supra ossa defunctorum*, mention his brother Johannes de Dompnopetro, and another brother Petrus de Dompnopetro clericus, notary Nycholaus Cuaneti, 09 mar 1450. (NT description now catalogued as C XXII NF10704.)

No. 56: Williermus de Dompnopetro filius quondam Anthonii de Dompnopetro burgensis Aventhice with approval of Petrus Uldrigon notarius tutor meus, sells to Dominus Uldricus Perrini capellanus et rector capelle hospitalis Beate Marie Virginis de Aventhica, similar to the preceding items, notary Nycholaus Cuaneti, 09 mar 1450. (NT description now catalogued as C XXII NF10706.)

No. 57: Petrus Pugin de Aventhica with approval of his wife Jaqueta sells to Petrus Blanchod burgensis Aventhice, notary Petrus Uldrigon, 01 may 1451. (NT description now catalogued as C XXII NF10707.)

No. 58: Henricus dictus Bonjor alias Bescheria burgensis Aventhice sells to Dominus Uldricus Perrin capellanus capelle hospitalis Beate Marie Virginis de Aventhica et Johannes de Radice capellanus capelle Beati Michaelis Archangeli fundate in ecclesia parrochiali Beati Martini de Aventhica *supra ossa defunctorum*, notary Nycholaus Cuaneti, 19 dec 1452. (NT description now catalogued as C XXII NF10716.)

No. 59: Otho Perryn de Aventhica sells to Dominus Girardus Medici capellanus curatus parochialis ecclesie Sancti Martini Aventhice, notary Nychodus Bonjor, 12 jun 1452. (NT description now catalogued as C XXII NF10715.)

No. 60: Franciscus de Aventhica domicellus filius quondam Nobilis Othonis de Aventhica, donation to Dominus Johannes de Radice capellanus Aventhie procurator et procuratorio nomine totius venerabilis cleri Aventhice, notary Petrus de Dompnopetro junior, 25 jul 1459. (NT description now catalogued as C XXII NF10729.)

No. 61: Johannes Godaleti notarius burgensis Aventhice sells to Dominus Girardus Medici curatus ecclesie parochialis Beati Martini de Aventhica, notary Nycholaus Cuaneti, 09 may 1461. (NT description now catalogued as C XXII NF10739.)

No. 62: Petrus Agnetaz lathomus residens Aventhice et Perrisonna eius uxor sell to Anthonius Campanat et Nychodus Giviliat (=Ginilliat?) burgenses Aventhice rectores et rectorio nomine candele agricolarum Beate Marie Virginis de Aventhica, notary Johannes de Dompnopetro, 04 mar 1463. (NT description now catalogued as C XXII NF10745.)

No. 63: Johannes de Radice de Aventhica cappellanus sells to Discretus Petrus de Dompnopetro clericus rector hospitalis pauperum Beate Marie Virginis de Aventhica, 14 solidi census, assigned on the house of the vendor that he had purchased from the buyer, in Avenches, adjacent to property of Mermetus de Voudri and Petrus Sapientis, notary Johannes de Dompnopetro, 07 nov 1469 (but Anno 1466 in the title). (We were unable to locate any reference to this document in the catalogue of the ACV.)

No. 64: Petrus Agneta residens in Aventhica et Perrussona eius uxor sell to Dominus Johannes de Radice capellanus tanquam procurator et procuratorio nomine venerabilis cleri Aventhice, notary Nychodus Bonjor, 13 nov 1469 (according to title, but text says 1409, an obvious copying error). (NT description now catalogued as C XXII NF10790, dated 13 nov 1469.)

No. 65: Henricus Bonjor de Aventhica sells to Dominus Girardus Trinchent capellanus rector et rectorio nomine hospitalis Beate Marie Virginis de Aventhica et Dominus Johannes de Radice capellanus rector et rectorio nomine capelle Beati Michalis Archangelli fundate in ecclesia parrochiali Beati Martini de Adventhica *supra ossa defunctorum*, notary Nychodus Bonjor and copied after his death by Johannes de Dompnopetro, 16 jan 1469. (NT description now catalogued as C XXII NF10791.)

No. 66: Petrus Tacholaz burgensis Aventhice sells to Dominus Girardus Trinchetti capellanus tanquam rector capelle Beate Marie Virginis hospitalis Aventhice, notary Nychodus Bonjor, 29 may 1469. (NT description now catalogued as C XXII NF10778, closely related to NF 10779, same date.)

No. 67: Dompnus Girardus Trinchent de Aventhica capellanus procurator et procuratorio nomine venerabilis cleri Aventhice, accensation for Petrus Bonjor burgensis Aventhice, notary Nicodus Bonjor and copied after his death by Johannes de Dompnopetro, 08 may 1472. (NT description now catalogued as C XXII NF10805.)

No. 68: Franciscus de Aventhica domicellus filius quondam Nobilis Othonis de Aventhica sells to Dominus Girardus Trinchent capellanus rector et rectorio nomine capelle hospitalis pauperum Beate Marie Virginis de Aventhica, notary Johannes de Dompnopetro, 28 jun 1475, with redemption 05 sep 1498, same notary. (NT description now catalogued as C XXII NF10813, which gives the date of the redemption as 04 sep 1498.)

No. 69: Anthonius et Girardus Rosset de Aventhica fratres sell to Dominus Girardus de Dompnopetro capellanus procurator et procuratorio nomine venerabilis cleri Aventhice, relates to bequest by Johanneta relicta Johannis Rosset quondam patris nostri pro suo anniversario annuatim, notary Nychodus Bonjor and copied after his death by Johannes de Dompnopetro, 14 jan 1476. (NT description now catalogued as C XXII NF10821.)

No. 70: Anthonius et Girardus Rosset fratres filii quondam [Johannis] Rosset de Aventhica (see previous item), sell to Dominus Johannes de Radice capellanus rector et rectorio nomine capelle Beati Michaelis Archangeli fundate in ecclesia parrochiali Beati Martini in Aventhica *supra ossa defunctorum* et Girardus Trinchent capellanus et rector ac rectorio nomine capelle hospitalis Beate Marie Virginis de Aventhica, various censes owed by various parties, notary Johannes de Dompnopetro, 18 mar 1476. (NT description now catalogued as C XXII NF10822.)

No. 71: Franciscus de Aventhica domicellus filius quondam Nobilis Othonis de Aventhica, sells to Johannes Long de Aventhica saltor rector et rectorio nomine animarum pulgatorii fidelium defunctorum in ville Aventhice erectarum, notary Nychodum Bonjor and copied after his death by Johannes de Dompnopetro, 01 oct 1476, with redemption recorded by the same notary 08 sep 1498. (NT description now catalogued as C XXII NF10818, closely related to NF 10819.)

No. 72: Otho Perryn de Aventhica sells to Dominus Johannes de Radice capellanus Aventhice tanquam altarista et rector capelle Sancti Michaelis fundate in ecclesia Sancti Martini, notary Johannes Goddaleti and copied after his death by Dominus Franciscus “Dempterii” (=de Dompnopetro?), 22 sep 1477. (NT description now catalogued as C XXII NF10823.)

No. 73: Franciscus de Aventhica domicellus filius quondam Nobilis Othonis de Aventhica sells to Dominus Girardus Trinchent presbiter rector et eo nomine altaris sub vocabulo Beate Marie Virginis in hospitali pauperum fundati, notary Petrus de Dompnopetro, 03 jn 1483 style of the Annunciation. (NT description now catalogued as C XXII NF10836.)

No. 74: Nychodus Micholaz alias de Eysi natus quondam Mermeti Micholaz de Eysi, sells to Dominus Petrus Grimualis (=Grunivallis) capellanus rector capellanie Beate Marie Virginis fundate in ecclesia parrochiali Aventhice, notary Petrus de Dompnopetro and copied after his death by Johannes de Dompnopetro, 23 aug 1487. (NT description now catalogued as C XXII NF10844, where the record is called Petrus Communalis.)

No. 75: Petrus Grimualis (=Grunivallis) capellanus et rector capellanie Beate Marie Virginis fundate in ecclesia parrochiali de Aventhica, et Anthonius Botterel burgensis Aventhica, dispute, relates to a cense owed by Conodus Botterel recorded by quondam Petrus Cuaneti 26 sep 1418, notary Petrus de Dompnopetro and copied after his death by Johannes de Dompnopetro, 23 aug 1487. (NT description now catalogued as C XXII NF10842, where the rector is called Petrus Communalis.)

No. 76: Franciscus de Aventhica domicellus sells to Dominus Franciscus Demptrii (=de Dompnopetro?) capellanus Aventhice rector et eo nomine capellanie Sancti Petri in Ecclesia parrochiali Aventhice fundate, notary Petrus de Dompnopetro and copied after his death by Johannes de Dompnopetro, 20 apr 1491. (NT description now catalogued as C XXII NF10855.)

No. 77: Otho de Dompnopetro filius quondam Petri de Dompnopetro de Aventhica sells to Dominus Franciscus Demptrii (=de Dompnopetro ?) capellanus et rector capelle ad honorem et sub vocabulo Sancti Petri Apostoli in ecclesia parrochiali Sancti Martini Aventhice, notary Petrus Ginivalis (=Grunivallis) curie dicti decanatus Aventhice, 09 nov 1492. (NT description now catalogued as C XXII NF10857.)

No. 78: Petrus Grinivalis capellanus Aventhice, foundation of a capella Beate Marie Virginis in ecclesia parrochiali Aventhice, ante altare Sancte Crucis in capella Beate Marie Magdelenes Aventhice, various specifications of liturgy, notary Petrus de Dompnopetro and copied after his death by Johannes de Dompnopetro, 26 apr and 03 jul 1494. (Original now catalogued as C V a 2338 and NT description as C XXII NF10867, dated 26 apr and 03 jul 1495.)

No. 79: Girardus de Oleres sells to Dominus Petrus Regnaud capellanus Aventhice, notary Petrus de Dompnopetro, whose registers were entrusted after his death to Anthonius Cuaneti (but the signature says Petrus Cuaneti, perhaps an error for Petrus de Dompnopetro?), 06 mar 1495 style of the Annunciation. (NT description now catalogued as C XXII NF10868.)

No. 80: Petrus Jaquimel de Dompnathecla sells to Dominus Anthonius de Boccens capellanus curatus et eo nomine ecclesie de Sancta Thecla, notary Petrus de Dompnopetro and copied after his death by Anthonius Cuaneti, 01 may 1496 style of the Annunciation. (NT description now catalogued as C XXII NF12360.)

No. 81: Petrus de Dysy burgensis Aventhice sells to Dominus Petrus Rignaud capellanus procurator et eo nomine venerabilis cleri sacerdotalis Aventhice, notary Petrus de Dompnopetro and copied after his death by Anthonius Cuaneti, 12 sep 1496. (NT description now catalogued as C XXII NF10870.)

No. 82: Othonus Blain (probably should be read as Blam, as written by many notaries of the 14th-16th Centuries) capellanus Aventhice sells to Dominus Petrus Grinivallis capellanus..., notary Petrus de Dompnopetro and copied after his death by Johannes de Dompnopetro, 17 dec 1498. (NT description now catalogued as C XXII NF10875.)

No. 83: Francesia filia quondam Petri Jaquimel de Dompnathecla uxor Petri Blain (=Blan, Blam) residens in dicto loci sells to Dominus Petrus Condevallis (=Grunivallis ?) capellanus velut vicarius ecclesie parochialis Aventhice, notary Petrus de Dompnopetro notarius et burgensis Aventhice and copied after his death by Johannes de Dompnopetro, 15 jun 1498. (NT description now catalogued as C XXII NF10874.)

No. 84: Henricus Forney de Aventhica sells to Petrus de Disy burgensis Aventhice rector et gubernator ac eo nomine candele agricolarum Beate Marie Virginis de Aventhica, notary Petrus Bonjor, 03 feb 1498. (NT description now catalogued as C XXII NF10876.)

No. 85: Jacobus Rondel de Certion sells to Dominus Anthonius de Boccens curatus Sancti Stephani de Dompnathelca acque Petrus Rossalet junior et Nycodo Solier de Villareppo rectores et gubernatores ecclesie Sancti Stephani de Dompnathecla, notary Petrus Bonjor, 23 mar 1500. (NT description now catalogued as C XXII NF12361.)

No. 86: Johannes filius quondam Johannis de Villareppo antenatus (but throughout the rest of the text he is Johannes *de Bellaripa* – Villareppo is probably an error by the copyist) sells to Dominus Petrus Gignilliat capellanus Avenchice procurator et procuratorio nomine venerabilis cleri Aventhice, cense, notary Petrus Bonjor, 11 feb 1505. (NT description now catalogued as C XXII NF10890.)

No. 87: Petrus Gignilliat capellanus Adventhice filius Girardi Gignilliat burgensis Adventhice sells to Dominus Glaudius Fornerod de Dompdidier vicarius ecclesie parochialis Adventhice, notary Anthonius Perrin, 13 aug 1505, witnesses Girardus de Mercie rector ville Adventhice, Girardus Guysan vexillifer (=Banneret), et Girardus Rosset. (NT description now catalogued as C XXII NF10888.)

No. 88: Nicodus Barraud de Dompnathecla sells to Dominus Franciscus Pignard (text says Piguard) capellanus procurator et eo nomine venerabilis cleri Adventhica, cense, notary Anthonius Perrin, 19 may 1506. (NT description now catalogued as C XXII NF10891.)

No. 89: Johannes Gignilliat capellanus filius quondam burgensis Adventhice (evidently the copyist has omitted the name here !), bequest to the capella Beate Marie Virginis fondata in hospitali Adventhice represented by its rector and governor Glaudius Gignilliat, notary Anthonius Perrin, die festi Sancti Mathei Apostoli 1517. (NT description now catalogued as C XXII NF10920.)

No. 90: Johannes Gignilliat capellanus Adventhice procurator et procuratorio nomine venerabilis cleri sacerdotalis Adventhice, with approval of Petrus Cuanet, Franciscus Pignard (text says Piguard), Anthonius Rosset, Johannes Perrocet, Glaudius Fornerod, Anthonius de Dompnopetro, and the undersigned notary, accensation for Anthonius Perrin notarius burgensis

Adventhice, notary Petrus Gignilliat capellanus dicti loci Adventhice, 18 may 1518. (NT description now catalogued as C XXII NF10927, dated 18 may 1519.)

No. 91: Anthonius Rosset capellanus Adventhice rector et altarista capellanie Sancti Petri in Cathedra in the parish church of Avenches, “permutation” in favor of Johannes de Merier burgensis de Adventhica, notary Dominus Petrus Gignilliati condam capellanus Adventhice and copied after his death by Johannes de Dompnopetro, 10 mar 1521 style of the Annunciation. (NT description now catalogued as C XXII NF10940.)

No. 92: Glaudius Jaquimel meo et Nicodi filii mei cum me inclusi nominibus de Dompnathecla sells to Dominus Johannes Ponthoux capellanus Adventhice velut rector et altarista ac eo nomine capellanie Domine Nostre de Pietate in ecclesia Beate Marie Magdalene Adventhice fondate et dotate, assisted by Otho Tachollaz rector et gubernator dicte ville et communitatis Adventhice, notary Petrus Gignilliat, 21 sep 1523. (NT description now catalogued as C XXII NF10946.)

No. 93: Thomas Sonnallion vicarius Adventhice rectorque et rectorio nomine capellanie Beate Marie Virginis hospitalis pauperum de Adventhica, and Claudius Myonton (Mionton) and his children as heirs of the late Petrus Curtier de Oleyres, dispute about a cense, settlement, notary Johannes de Dompnopetro, 19 dec 1531. (NT description now catalogued as C XXII NF10956 and another copy NF10958.)

No. 94: (In French) Françoys Gignilliat secretaire de Lausanne filz de defunct Johannes Gignilliat ancient general commissaire de l’Evesché de Lausanne sells to Discret Jacobe Regnaulx notayre et conseillier d’Avanche modern procureur et à icelluy nom des biens ecclesiastiques du dict lieu d’Avanche, une maison et grange contigues sises en la ville d’Avanche au Ryu Devant..., 240 florins, notary Anthoine Guysan, 21 jun 1556, witnesses Jehan Guysan chastelein dudit Avenche, etc. (NT description now catalogued as C XXII NF10971.)
