

**ACV Fi 286      Terrier for Nobiles Johannes (and later his son Petrus) et Guilliermus filii quondam Nobilis Jacobi filii quondam Nobilis Claudius Mistralis de Coctens, 1506-1510, commissaires Gabriel Barrillieti and Bernardus Reverchon.**

Unlike some similar terriers, Fi 286 does not include a reconnaissance by the holders of this “noble fief” to their seigneur, Amedeus de Viry, Seigneur and Baron of Mont-le-Vieux and Rolle. However, the text of what was then probably the most recent settlement between the Mistralis de Cottens family and the de Viry family is included, dated in 1451. The “quernet” Fi 55, dated in 1543 but clearly based on much earlier material, closely follows the order and content of Fi 286 for the properties and rents subject to the family of Mestral de Cottens, in the person of Petrus Mistralis, but Fi 55 leaves a blank space for the name of his father, implying some degree of haste in compiling Fi 55 – it should not have been too difficult in 1543 to discover that information! Today, the problem seems somewhat murky. Some sources say that Petrus was another son of Jacobus, and thus another brother of Johannes and Guilliermus, or else another grandson of Claudius (perhaps through Georgius, brother of Jacobus ?).

There is also external evidence that Johannes died before his brother Guilliermus, leaving a son Petrus Mistralis : ACV C XVI 56/11, 12 apr 1514, settlement of a dispute involving the testament dated 30 apr 1513 by Cristofora, daughter of Jacobus de Collumberio, Seigneur de Bussy, wife of Noble Humbertus de Praroman and widow of Noble Johannes Mistralis Seigneur de Cottens her first husband. The parties to the dispute were her second husband, Humbertus de Praroman, and Guilliermus Mistralis, Seigneur de Cottens, as guardian of her minor (i.e., below the age of 25 years) children by Johannes Mistralis. The children were Petrus and (apparently—the text is said to be heavily damaged) *Francesia*. From this document, we can surmise that Johannes Mistralis must have died soon after the completion of Fi 286, in order for his widow already to have remarried by 1513. Another document, ACV P Château de Vufflens 615 d, dated the next day, 13 apr 1514 (but this is an unsigned copy of the original transaction), names the same children as Petrus and *Janna*. Shortly thereafter, P Château de Vufflens 617, Guilliermus Mistralis, Seigneur de Cottens, concluded a marriage contract with Janna de Montherant. Johannes Mistralis apparently had at least one other daughter, who had already married by the time of her mother’s death : ACV C V a 2537, dated 15 sep 1526, mentions a bequest from Louise, daughter of Noble Jean Mestral, Seigneur de Cottens. Louise had married Guillaume Musard, and, by 1526, her son Louis Musard had apparently reached the age of majority. By January 11, 1542 (C XVI 169/42), Pierre Mestral is mentioned as Seigneur de Cottens. The apparent connection of Petrus Mistralis with Cristofora de Collumberio, wife of Johannes Mistralis, is strengthened by additional documents that show Petrus was named as a substituary heir by Noble Philibert de Colombier (=Collumberio).

The origin of this situation is found in P Château de Vufflens 345, a codicil to the testament of Philibert de Colombier, Seigneur de Vufflens-le-Château, dated 04 nov 1544, in which he decreed, in case he had no living children by his wife Claude de Menthon at the time of his death, that his heirs would be Petrus Mistralis, Seigneur de Cottens for one half, and the three

sons of the late François de Laconay for the other half. These arrangements make sense if Petrus Mistralis were the son of Johannes Mistralis and Cristofora de Collumberio: From other documents in the P Château de Vufflens collection, Jacobus de Collomberio or de Colombier was a son of Richardus de Collumberio. Jacobus had a brother Andreas and a sister Peroneta. Peroneta married Gabriel de Laconay and was the grandmother of the three sons of François de Laconay named in the codicil. Jacobus was the father of Cristofora, mother of Petrus Mistralis. Andreas was the father of Philibertus de Colombier. When Philibertus prepared his testament and codicil, his closest relatives were his first cousins once removed: the de Laconay brothers and Petrus Mistralis. If Petrus Mistralis were not a descendant of the de Colombier family, his nomination as an heir of Philibertus would be inexplicable. From this analysis, it appears also that Guillermus Mistralis must have died without descendants, and so, upon the death of Guillermus, Petrus Mistralis became the sole Seigneur de Cottens.

Corroborating evidence is found here in Fi 286. While most of the reconnaissances are dated in 1506-1508, there are several dated in 1509 and one in 1510. Two of those from 1509 (fols. 132v and 135v) concern new leases (the leases themselves are included on fols. 243v and 249), which reveal that Johannes Mistralis had died, and that his son Petrus Mistralis now held the fief of Cottens jointly with his uncle Guillermus Mistralis, while the rest mention that the reconnaissance is being made, not to the noble brothers (Johannes and Guillermus), as is stated in the earlier reconnaissances, but now, in 1509, to the noble uncle and nephew (Guillermus and Petrus). The earliest such reference is dated 17 mar 1509 (fol. 224v). Proceeding backward chronologically into 1508, we found the earliest indication of the death of Johannes in the reconnaissance on fol. 115v, dated 18 aug 1508, where the commissaires describe themselves as *commissariorumque et receptorum recognitionum et extentarum Nobilium virorum Guillermi Mistralis filii defuncti Nobilis Jacobi Mistralis de Coctens et Petri Mistralis dicti Nobilis Guillermi nepotis filii defuncti Nobilis Johannis filii predicti Nobilis Jacobi Mistralis et dicti Nobilis Guillermi fratris*. Evidently Johannes had died sometime between 03 apr 1508 (fol. 166), the latest date on which the Seigneurs de Cottens are described as *nobilibus fratribus*, and 18 aug 1508.

Fi 55 enumerates additional properties and tenants subject to the Mistralis de Cottens family that are not included in Fi 286, suggesting that sections for Villard supra Perruys, Vinsel, and Beria have been lost from Fi 286, before the final compilation and numbering of pages. The unexplained fragmentary text on fol. 224 seems to be a remnant of the missing sections.

Below the paraphe, a summary of the cense for this (incomplete) reconnaissance, *unum potum oley ad mensuram Nyviduni in qualibet Dominica Bordarum solendum*. The cense indicated does not correspond to any reconnaissance in this volume, so it may be that fols. 224-227 were lifted out of another volume, and the text on fol. 224 is simply an irrelevant remnant of whatever that other volume contained. However, we note that the corresponding section of the quernet Fi 55 (fols. 743 (b) – 765 (c)), which otherwise generally follows the order and content of Fi 286, contains additional tenants in Villard supra Perruys, Vinsel, and Beria that are not mentioned in Fi 286, raising the possibility that some material was lost or omitted during the compilation of Fi 286. In fact, the cense of *unum potum oley* could be the one mentioned in Fi 55, fol. 761v (a), for Johannes Reymondi apothecarius Lausanne for a parcel at Vinsel, the only tenant of the Mestral de Cottens family having exactly that cense in Fi 55.
