- 25 19 sep 1590, Françoise fille de feu Jean Baddoz de Cremin, with his cousin Facioz (=Boniface) Baddoz, owe debt to Egrege François Bettex notaire et curial de Lucens and his wife Jeanne fille et heritiere de feu Jean Centlivres, vivant recepveur de Nos Tres Redoubtez Seigneurs de Berne audit Lucens.
- 26 05 oct 1590, Exchange: Louis Jordan and Claude Deytard.

27 18 nov 1590, Testament: Henri Perdonnet de Vicherens (=Vucherens), naming as heirs his sons Henri and Noel, a son Andrey at Vevey “pource qu’il a beaucoup mangé”, and an unnamed daughter of his late son Claude Perdonnet.

27v 29 dec 1590, Mariage: Henri Cavin lieutenant de Vulliens to Catherine veuve de Pierre George vivant bourgeois de Moudon and also of Pierre Maillard, represented by her son François Maillard, and her brother ? Anthoine Pidoux.

28v 15 mar 1591, Subhastations: at the request of Michel Frossard notaire et secretayre de Moudon, regarding debts of Discret Pierre Creaturaz.

30 29 aug 1591, Mariage: Nicod Estoppey cousturier residant à Moudon, to Pernon fille de George Gillian hoste et bourgeois de Moudon, with quittance.

32v 31 oct 1591, Pierre Degiez sells to Guillaume Frossard.

33 02 nov 1591, Isaac Jaccaux residant à Moudon cedes to Louis Fabri bourgeois de Moudon.

33v 02 dec 1591, commune of Vucherens sells to Philippe Cerjat.

34v 02 dec 1591, lease for the preceding item.

35 No date found, Acte d’association for the commune of Denisiez, for François Moredoz. (An apparent duplication of this item is found on fol. 42v, dated 25 mar 1592.)

36 12 jun 1592, Exchange: Seigneur de Denisiez (i.e., Philippe Cerjat) and François Broye.

38 20 feb 1593, George Folliet bourgeois de Moudon sells to François Crisinel.

- 41v 09 mar 1592, Mariage: Discret Jaques fils de feu François Frossard de Brenles bourgeois de Moudon, assisted by his uncle Nycolas Morattel (this family from Payerne) bourgeois et general de Berne, to Magdelaine fille de feu Noble Anthoine Cerjat, represented by her mother Jeanne widow of the said Anthoine, and by her cousin Philippe Cerjat.
- 42 12 mar 1592, Mariage: Jaques du Russel demeurant à Olens to Anthoene fille de feu _____ (blank space), assisted by her cousin Daniel Fremont de Corenson.
- 42v 25 mar 1592, Act of association for François Moredoz, apparent duplication of the transaction on fol. 35, which seemed there to be undated.

Later, she ceded this right to her husband, as recorded by Egrege Jaques Richard, 02 may 1583. On 26 may 1583, Jaques Voulruz ceded his rights to Egrege Baltazard Duthey bourgeois et conseiller de Moudon. Now, in 1586, Baltazard cedes these rights to Philippe Cerjat.

- 55 22 nov 1593, Partage: Guillaume et Pierre Buttet fils de feu Egrege Anthoine Buttet vivant conseiller et bourgeois de Moudon.
- 56 27 dec 1593, Mariage: Colas (i.e., Nicolas) Mamgrin ? (or possibly Manigran or similar ?) demeurant à Olens, to Françoise sister of Guillaume Brochon de Allerin demeurant à Brenles, with quittance.
- 57 15 jan 1594, Exchange: Jean Trolliet et Bertran Duret, see below, fol. 59, for the ratification by the wife of Duret.
- 57v 28 jan 1594, Pierre Girard sells to François fils de Claude Girard.
- 58 28 jan 1594, Jaques Dumont sells to Isaye Chambaz.
- 58v 01 feb 1594, Passage à clos for the Seigneur de Denisiez.
- 59 23 feb 1594, Bertaz wife of Bertran Duret, ratification of the exchange on fol. 57, above.
- 59v 20 feb 1594, Guillaume Buttet bourgeois de Moudon sells to Egrege Daniel Nycod notaire et conseiller son beaufrère, also involving his brother Pierre Buttet.

68v 04 sep 1596, Settlement, concerning: (1) Discret Jean Degissey ? citoyen de la ville de Langres, notaire de Collombier au conté de Neufchastel, and Cosmé Janinet cyrurgien et bourgeois de Moudon, uncle and nephew (Janinet is apparently the uncle of Degissey ?), (2) Marguerite Nardent, present wife of Degissey, and (3) Anne Guillaume, first wife of Cosmé Janinet, the “adoption et creditation” of this agreement was dated 04 nov 1595, as recorded by Jaques Richard.

70 13 sep 1596, Noble Abraham Espaz donzel de Moudon cedes to Noble Jean Charvin bourgeois de Vevey.

70v 26 sep 1596, Mariage: Jean Luisi to Françoise fille de George Gillian, with quittance.

71 No date found, Mariage: Petreman (Petremand) Gavoens cyrurgien et bourgeois de Moudon, to Anne fille de Adam Durant bourgeois d’Orleans à present marchand de drap resident audit Moudon.

72v 03 jan 1597, Philippe Cerjat et Anthoine Bize, regarding a debt that Bize owes to Abraham Sturler, senateur de Berne.

73 05 jan 1597, Jean Barbey sells to Guillaume Frossard.

73v 17 jan 1597, Pierre Vuagnieux metral de Vucherens sells to Claudaz relaissée de feu Claude Hugogniez de Carrojoz.

74 17 jan 1597, Pierre Vuagnieux acting as tuteur de Magdelaine fille de feu Andrey Guilliet vivant resident à Vucherens sells to Clauda relaissée de feu Claude Hugogoniez.

74 31 jan 1597, Exchange: Pierre Vuaguieux metral de Vucherens and Claude Deytard de Vucherens.

74v 12 feb 1597, Mariage: Guillaume Buttet conseiller et bourgeois de Moudon, to Jeanne fille de feu Noble Pierre Lois (=Loys) vivant citoyen de Lausanne, represented by his widow Urbaine Chalet (=Challet). Guillaume Buttet has children by his previous wife. Challet has other younger daughters. Another daughter of the late Noble Pierre Loys is now the wife of Noble Jaques Polier of Lausanne, with quittance.

76v 17 mar 1597, Pierre Degiez sells to Claude Berthod his beaufrère.

77 No date found, title only, Testament: Jean Pidoux bourgeois de Moudon, no text, incomplete.

78 09 aug 1597, Testament: Anthoine Burnand favre bourgeois de Moudon, naming his brothers Humbert, Pierre, et François Burnand de Vulliens, uncles Jean et Guillaume Burnand de Vulliens, his wife not named, mother not named, sister not named, beauxfrères Gaspard and Pierre Jossevel, uncle Guillaume Frossard, belle-mère Bernardine Chambriere.

79v 21 aug 1597 ?, Testament: Noble Sebastian Loys, naming son and daughter by his wife Marguerite de Glannaz, and relatives the two Seigneurs de Chesaux and Noble Samuel d'Aubonne, brothers Noble Michel and Philippe Loys, sister Jeanne Loys wife of Noble Daniel Chalon.

80 11 oct 1597, George Folliet bourgeois de Moudon acting for Claudaz and Beneyte daughters of the late Claude Terraux de Cheriez sells to Françoise Pittet hoste de Cheriez.

81 18 oct 1597, Testament: Pierre Espaz donzel, naming daughter Beneyte, wife Marguerite, mother Catherine Dutruict, who is now the wife of Cosmé Janinet chirurgien et bourgeois de Moudon.

82v 28 nov 1597, Pierre Mojonnier de Chesalles sells to Michel Frossard l'ainé de Brenles bourgeois de Moudon.

83 08 dec 1597, Settlement: Marguerite Sordet veuve de feu Pierre Espaz contre Catherine Dutruict femme moderne de Cosmé Janinet chirurgien bourgeois de Moudon et mere du feu Pierre Espaz, and Claude Sordet bourgeois de Culiez (=Cully) is the father of Marguerite.

84 20 feb 1598, Pierre Girard de Deniziez sells to Jean Lauffrin of Prevondavaux.

85 23 apr 1598, Mariage: Pierre Rechoz bourgeois de Moudon to Anne fille de Michel Frossard de Brenles, assisted by her uncles Guillaume Frossard bourgeois de Moudon and François Estoppey de Granges, and her relatives Michel Frossard secretaire ballivale de Moudon, Jaques Frossard, Wolff Frossard, Pierre Frossard, et moy sousigné (i.e., the notary Pierre George).

86 26 apr 1598, Settlement, concerning the marriage of Pierre Berthod cousturier et bourgeois de Moudon to Catherine fille de Beney Cornaz bourgeois de Moudon, the marriage contract recorded by Discret Anthoin Pidoux 02 jul 1590. Now Louis, Claude, and Guillaume Berthod bourgeois de Moudon, as heirs of their late brother Pierre Berthod, settle their claim against Pierre Riguet and his wife Catherine, daughter of Beney Cornaz and widow of the late Pierre Berthod.

87v 29 apr 1598, Jaques fils de Claude Crisinel de Deniziez sells to Françoise relaissée de feu Bernard Richard demeurante à Deniziez and guardian of her children.

88 02 jul 1599, Pierre Rechoz bourgeois de Moudon, exchange with Anthoine fils aisé de feu Jean Trolliet and Françoise fille de feu Jaques Rechoz and wife of Jaques, another son of the said late Jean Trolliet.

89 14 oct 1599, Mariage: Nicod Estoppey bourgeois de Moudon to Anne fille de Abraham Fourniez, with quittance.

89v 15 may 1598, Philippe Cerjat sells to Claude Jatton de Peney.

90 15 may 1598, cense for the above sale.

90v 30 sep 1598, Anthoin Visin bourgeois de Moudon sells to Anthoine Myvillaz.

91 11 dec 1598, Exchange: Jaques Guex bourgeois de Moudon, and Rosaz relaissée de feu Claude Perrin as guardian of their daughter Pernon.

92 22 dec 1598, Guillaume Berthod de Moudon sells to Guillaume Frossard.

92 No date found, title only, Aymé Dutoit, Jaques and Pierre Busigny, sell to Jaques fils de feu Pierre Ansel bourgeois d'Yverdon.

93 04 mar 1599, Anthoine Bize sells to Guillaume Frossard.

93 02 may 1599, Françoise Bouchard femme de Bernard Broschon bourgeois de Moudon, and Anthoin Brochon, brother of Bernard, sell to Pierre Rechoz.

94 23 feb 1600, Mariage: Jaques fils de Jean Baudet to Jeanne fille de George Gillian, whose other daughters are married to Aymod Estoppey and Jean Luisi, with quittance.

94v 17 dec 1599, Claude Berthod bourgeois de Moudon sells to Nicod Brun.

95 18 dec 1599, Exchange: Françoise Bocharde wife of Bernard Broschon, acting for him, and François Baddoz habitant à Moudon.

95v 12 feb 1600 ?, Egrege Daniel Burnat coadmodiataire de la seigneurie de Vulliens, lods for the preceding exchange.

98 01 jan 1599, Philippe Cerjat, lods for sale by Jerome Masset to Noble Isaac du Pré demeurant à Yverdon.

98v 02 may 1600, Bernardine relaissée de feu Jaques Riguet vivant bourgeois de Moudon, and Anthoine Jayet d'Hermenges bourgeois de Moudon, as guardians for the heirs of the late Jaques Riguet, and Daniel, son of the said Jaques Riguet, sell to Philipbert de Praroman donzel de Lausanne.

99v No date found, incomplete, Mariage: Jaques Dufey de Palesieux, to Jaquemaz Duboz de Peney.

100 08 mar 1600, Prononciation: Communes of Chavannes and Chesalles, regarding pasturage and pigs.

[101] 09 may 1604, Pierre Girard sells to David et François Crisinel, brothers.

[101v] 05 mar 1587, Testament: Jean fils de feu Louis Faucheres de Bussy bourgeois de Moudon, naming his daughter Pernon, nephews François et Jaques fils de feu Pierre Faucheres, wife Antheyne fille de Claude Jorey de Vulliens, fils donné Jaques, brother George, and George's children Susanne, Nicod, and Jean.

[103] 23 nov 1606, Mariage: Jaques fils de François Wagnierres bourgeois de Moudon to Thivenaz fille de François Fouchierres de Bussi, assisted by her uncle François Vauruz bourgeois de Moudon, witnesses include Pierre Dutoit ministre, Pierre et Moyse Vagnierres freres, Pierre Dutoit, Jean Borel son beaufilz, tous bourgeois de Moudon, with quittance.

[104] 19 jun 1609, Jaques Dumont de Denisiez bourgeois de Moudon, with his son Pierre (but in the title, he is called Jaques), sell to David fils de François Crisinel de Denisiez.

[105] 20 feb 1610, Jean Pyot de Thierrens, exchange with Isaye Chambaz de Denisiez as guardian of the heirs of the late Anthoine Girard.

[106] 15 apr 1609, David Janin diacre à Moudon charge ayant d'honneste Pierre Pontaux bourgeois d'Avenches cedes to Daniel Corthesy de Dompierre sur Lucens.
