

## Cecil County, Maryland Wills 1777-1810

*Briefly abstracted by John W. McCoy © 2010 (RealMac@aol.com)*

Due to the importance of Cecil Co. as a jumping-off point for migrations into Virginia, the Carolinas, Ohio, Western Pennsylvania, etc., and also because we found so many contradictory statements about particular wills from this county, we decided to abstract the early will books, attempting to get all of the heirs, and all of the dates. With this information, the genealogist will be able to find the full text on the microfilms. We happened to start with the Family History Library microfilm that has books "CC 3" to "FF 6".

The wills contain much additional information about slaves. Many are mentioned by name, and there are a few whose parents are named as well. We have not attempted to extract this information.

Some of the wills express confusion about whether the testators were living in Chester Co., PA or Cecil Co., MD, because of the boundary disputes of that period. We only list locations when there is specific information.

Some individuals are identified as Quakers in these records. This happens most often when they appear as witnesses who "affirm" rather than "swear" to the authenticity of a will.

Original spellings are used (barring typographical errors in the abstracts!), but names are frequently spelled in different ways in the same record. Alternate spellings attested within a given probate are shown in parentheses. When we have guessed, through internal evidence or otherwise, the modern equivalent of a particular spelling, we show that in parentheses with an equal sign: *Mevey (=McVey)*. Names that could not be read with certainty are indicated with a question mark. When the day of a month is not indicated, it is represented with a double question mark: *?? dec 1805*. In wills written by Quakers, months are usually indicated (even when the name of the month is not idolatrous) as "first month", "tenth month", etc. The point of reference for this style of dates, at least from the 1770's forward, is January, as shown in such constructions as "third month commonly called March" (book EE 5, probate 95).

Residual heirs daughters Ann, Sarah, and Susannah. Witnesses Valentine Carpenter, Michael Chairn? Proved 20 jun 1777. Recorded 16 mar 1778.

3. Jethro Baker (p. 7), 02 jun 1777, wife Ann, son Nathan <21, son Jethro <21 (land my father Henry Baker lived on in the Manor of Cecil Co.), daughters Siney and Lydia both <18. Executor James Orrack (Orrick). Witnesses Samuel Maffit, Andrew Reed, Thomas Silson. Proved 30 jun 1777. Recorded 16 mar 1778.
4. Elisabeth Hyland (p. 10), 06 oct 1775, son Isaac, son Nicholas, grand-daughters Mary, Elisabeth, and Meliscent Williamson all <16, daughter Meliscent Williamson, grand-daughter Racheal Lum, grand-daughter Elisabeth Hyland. Residual heirs Isaac Hyland, Nicholas Hyland, Meliscent Williamson, and Jacob Hyland. Witnesses Nicolas George, William Crouch, Michael Lum. Proved 28 jun 1777. Testimony of Stephen Hyland regarding changes to will in his presence 29 may 1777. Testator Elisabeth Hyland died the next day, 30 may 1777. Recorded 19 mar 1778.
5. Samuel Anderson of Millford (p. 13), 20 may 1777, wife Ann, daughter Sarah, brother John Anderson. Executors his wife and Samuel Maffit. Witnesses Matthew Taylor, John Anderson, Samuel Maffet. Proved 01 jul 1777. Recorded 19 mar 1778.
6. Nicholas Dorrell (p. 16), 28 jan 1777, son James Dorrel Fitchgarrell (=an attempt at Fitzgerald?), son Hyland Fitchgarrall, son Shaddrack Dorrell, all <14. Executor brother James Dorrell. Witnesses James Coppin, Joseph Pennington, Joseph Hutcheson. Proved 25 jul 1777. Recorded 20 mar 1778.
7. William Beddle (=Biddle) (p. 18), 12 mar 1776, wife Mary. Executors Andrew Miller, Jeremiah Taylor. After wife's decease, remainder of the estate will go to Andrew Biddle, son of Noble Biddle. Witnesses Joseph Cooper, John Howard. Proved 26 jul 1777. Recorded 20 mar 1778.
8. Nathaniel Chick (Cheek) millar (p. 20), 08 mar 1777, wife Mary, daughter Susannah, son Perigan?, daughter Sarah, daughter Tabitha, son Nathaniel, daughter Mary, daughter Nancy. Executor his wife. Witnesses (partly illegible) Peregrine Vandergrift, William ... Proved 28 jun 1777. Recorded 20 mar 1778.
9. Jean (=Jane) Borland of West Nottingham (p. 23), 04 mar 1777, son Samuel, daughter Racheal, son John, son James, sister Martha Hunter, son William. Executors sons John and James, friends James Maxwell and William Johnson. Witnesses Henry Anderson, William Coard (Cord), Elener Marquis. Codicil 03 jun 1777. Proved 20 aug 1777. Recorded 20 mar 1778.
10. Joseph Rich of the township of West Nottingham (p. 27), 07 nov 1775, wife Sarah, son Stephen, daughter Martha McReynolds, daughter Mary Blackburn, daughter Rachel Hains, daughter Hannah Hains, son Thomas. Residual heirs daughters Prudence Rich and Elizabeth Rich. Executor his wife. Witnesses Elisha Gatchel, James Evans, Nathan Harris. (nothing further for this entry)
11. John Veazey (p. 30), 04 mar 1776, eldest son Edward, third son William, daughter Rebeccah Sturgis (wife of Joseph Sturgis) including part of a pew at St. Stephen's Church, grand-daughter Susannah Veazey daughter of Rebecca Sturgis, fourth son Thomas Brockus Veazey. Executor Thomas Brockus Veazey. Witnesses William Coursey?, Lewis Price, John Ward. Proved 27 sep 1777. Recorded 22 mar 1778.

13. Richard Dobson (p. 35), 13 aug 1777, son George <21, son Stephen, daughter Mary (guardian: Mr. Samuel Wallis of Pennsylvania), step-daughter Cassandra Jacobs, step-daughter Gracey Jacobs. Witnesses James Booth, Abraham Mitchell, John Simpers. Proved 15 nov 1777. Recorded 30 mar 1778.

Mary Harrison widow (p. 38), 02 nov 1777, son Samuel Crockett; grandchildren Benjamin and John sons of Dr. Benjamin Crockett, Richard son of Philip Nelson, Gilbert, Samuel, and Benjamin sons of Gilbert Crockett, Ann and Elizabeth daughters of the aforesaid Samuel Crockett, Philip and Burgess sons of Philip Nelson aforesaid, Sarah and Gilbert children of aforesaid Dr. Benjamin Crockett. Executors son Samuel Crockett, grandson John Crockett. Witnesses Andrew Barratt, Casandra Durbin, Francis Boyd. Proved 22 nov 1777. Recorded 30 mar 1778.

16. Catharine Evans (p. 43), 07 apr 1777, sons John and Amos, daughter Margaret Moor, daughter Elianor Duguet. Executor son John. Witnesses Edward Dougherty, John Wood, John Stump. Proved 26 jan 1778. Recorded 04 apr 1778.
17. Robert Thackery (p. 45), 21 oct 1777, eldest son James, daughter Racheal, wife Racheal. Residual heirs children James, Mary, Christy, Ann, Rebecca, Roberd (=Robert), Thomas. Executor his wife and son James Thackery. Witnesses Stephen Hyland, John Crouch, Rebecca Jones. Proved 10 feb 1778 (executor James Thackery withdraws). Recorded 04 apr 1778.
18. Samuel Ralston (p. 48), 16 dec 1777, brother William and sister Elizabeth Ralston of County Donegall near Castle Fin in Kingdom of Ireland. Executor friend Benjamin Bravard. Witnesses Andrew Wallace, Andrew Miller, William Hyde. Proved 10 feb 1778. Recorded 11 apr 1778.
19. James Wroth being a member of the Church of England (p. 49), 06 may 1777, son James, grand-daughter Tamar Childs, grand-daughter Amy Wroth daughter of son James, daughter-in-law Ruth Gofton, daughter-in-law Sarah Hayes. Residual heirs daughter Catherine Rice, daughter Mary Hanson, and children of my daughter Ann deceased. Executors friend John Hall, son James Wroth. Witnesses Henrietta Rachel Hall, John Credich, R. Seurrey Jr. Proved 12 feb 1778. Recorded 13 apr 1778.

John White of the township of East Nottingham (p. 52), 07 jun 1775, son William, son John, daughter Mary Shepherd, son Joshua, daughter Sarah Shepherd, son Jonathan (and Jonathan's son Jacob), wife Agnes, grandsons: John son of William White, Eley son of Samuel White, grand-daughters: Phebe White daughter of Patience White, Elizabeth White daughter of Samuel White. Executors his wife, son John, Archibald Job. Witnesses William Cole, Jesse Brown, George Day. Proved 27 mar 1778. (no recording date)
21. Nicholas Carter of Susquehannah Hundred (p. 56), 04 jun 1776, brother Nathaniel, friend Mordecai James, "Samuel, Thomas, and Edward Kelly, grandsons to Hannah Kelly". Residual heir friend Hannah Kelly. Witnesses Arthur Alexander, Robert McMaster. Proved 06 apr 1778. Recorded 03 jul 1778.
22. Thomas Cosden (p. 59), 09 apr 1778, daughter Catharane, children of brother Alphonso (not specified). Executor uncle James Cosden. Witnesses Thomas Price, Isaac Holt. Proved 12 apr 1778. Recorded 03 jul 1778.
23. Dennis Keys (p. 61), 15 apr 1777, Michael Connely, Edward Shields. Witnesses Benjamin Sluyter, James Tagus, Rebecca Whitesides. Proved 28 apr 1778. Recorded 03 jul 1778.

James Porter of Octorara Hundred (p. 63), 23 jan 1775, wife Elionor, son William, son Alexander, son Stephen, son James, daughters Elizabeth and Elionor, son George, nephew James Porter Ewing, daughter Mary Ewing. Mention of land in Cumberland Co., PA. Executors sons William and Stephen. Witnesses Nathan Ramsey, Thomas Porter, James

- Carrithers. Proved 27 apr 1778. On 04 jun 1778 widow accepts legacies in lieu of dower. Recorded 08 jul 1778.
25. William Barroll clerk of St. Stephen's Parish (p. 68), 30 mar 1778, son William, son Richard, mention of uncle Hugh Jones, son James, wife Ann, daughters Ann, Sarah, and Abigail. Executor his wife. Witness Joseph Lusby. Proved 05 may 1778. Recorded 09 jul 1778.
  26. Charles Whitelock (p. 72), 22 feb 1752, wife not named, son James, son Edward. Witnesses William Welsh, John Welsh. Proved 13 jun 1778 (by Andrew, son of John Welsh, and by Jean (=Jane) Commey alias Whitelock, who had possession of the will). Recorded 09 jul 1778.
  27. Maurice Rogers of Philadelphia, now of Worset Manor in Cecil County (p. 75), 24 jun 1778, wife Mary, cousin Alexander Foster, the youngest child of Thomas Rogers of Killard in the County of Waterford (Ireland), also minor bequests to Catharine Scott, Sarah Neile, Elizabeth Nixon, and Alexander Foster. Executors John Nixon, John Maxwell. Proved 20 jul 1778. Recorded 11 sep 1778.

  33. John Holland (p. 91), 21 feb 1779, brother Thomas Bouchelle, mentions estate of his mother, Dr. Joshua Clayton. Residual heirs Margdalin McClary for her lifetime, then reverts to Dr. Joshua Clayton. Executor Dr. Joshua Clayton. Witnesses John Dockery Thompson, William Mathews, John McClary. Proved 29 mar 1779. Recorded 24 apr 1779.
  34. Mary Ward (p. 94), 02 apr 1779, son Peregrine Ward's four children (Peregrine Ward, Mary Chew Ward, Rebecca Ward, and Elisabeth Harrison Ward). Executor his son Peregrine Ward. Witnesses John Stoops, William Stoops, Henry Pryce. Proved 04 may 1779. Recorded 10 may 1779.
  35. Robert Lesslie (Laslie) (p. 96), 02 may 1779, wife Deborah, unnamed grandchildren, son Robert (among other properties, 1/2 of lot 12 in Charlestown, and 1/2 of lot 15 in Charlestown), son Thomas (the other 1/2 of lot 12 in Charlestown), son William (and William's son Robert and William's wife Christian Lesslie), grand-daughter Deborah (daughter of Thomas Lesslie), Thomas Nixon (other 1/2 of lot 15 in Charlestown), William Domaign ("plantation where he lives, left to me by my father"). Minor bequests to Dr. John Beard and Thomas Russel. Executors his wife and son Robert. Witnesses John Beard,

Samuel Paterson (Patterson) (p. 109), 01 apr 1779, wife Mary Patterson, nephew Michael Wallace (Wallis) second son of my sister Easter Wallis, brother John, nephew Samuel Patterson Wallis, eldest son of my sister Easter Wallis, sister Elizabeth Maxwell, nieces Sally and Polley Wallis. Residual heirs sisters Elizabeth Maxwell and Easter Wallis. Executors his wife Mary and Thomas Wallis. Witnesses John Hammond Cromwell, John Patterson, James Pallen. Proved 26 jun 1779. Recorded 16 jul 1779.

Codicil 03 oct 1777, John Emitt to be executor, witnessed by Ann South and Magdalene South. Proved 09 aug 1779. Recorded 14 feb [1780].
42. John Wilkinson planter (p. 118), 18 jul 1775, wife Mary, son Robert Wilkinson. Executor wife Mary. Witnesses James Barkey, Catharine Jenny, John Lesslie. Proved 2 nov 1779. Recorded 14 feb [1780].
43. John Rankin yeoman (p. 120), 29 may 1779, son Alexander, son Joseph, son John, son George, daughter Jane Flanagan, daughter Presila Rankin.
