We certify that one cow and calf, one bed, bedstead and furniture, the essential cooking utensils appraised in the within inventory, and the necessary tools or implements of trade (said McCoy being a Mechanic) were reserved to the widow and heirs and exempted from sale by administrators by an act of assembly of 1821 Vol. 1st page 538 of the Digest, the tools were sold at her instance and for her benefit and heirs. Given under our hands October 12th 1829. Wm. Gatewood, W. J. Wright admrs.

Wright Administrators of David McCoy deceased to settle with them as administrators aforesaid this day made this report which was examined and approved of by the Court and ordered to be recorded. [Editor's note: the figure of \$50 from the sheriff is evidently in error. It would have to be \$30 in order to result in the sum of \$287.93 shown carried into the next column. Or, the figure of \$287.93 is in error and the administrators would have owed the heirs \$15.08 \[^34.\]
