Separately, the bundle includes a complete French translation of the preceding four sheets, certified by Robillard at Nyon, 17 jul 1827. In turn, the signature of Robillard was authenticated by Snell, Assesseur de Paix. Finally, a separate subscription indicates the package was recorded by the Justice de Paix at Lausanne, 07 dec 1830, more than six years after the original power of attorney was drafted in Nicholasville.
